Information

Distrain

In a case regarding distraint the Enforcement Authority undertakes a research of assets. We then look for assets that can be subject to distraint, e.g. movable property, wages or tax paid in excess. Real estate or other forms of such property are only subject to distraint if you have expressly requested this.

Fee

Upon an application for enforcement a fee is imposed, a so called basic fee. A case for distraint continues without any time limit and the Enforcement Authority imposes a fee for each year the matter is dealt with. In addition, other costs relating to the enforcement may arise.

In order to terminate the proceeding you must, as applicant, withdraw your application.
